## Associate Membership Application

The OHCA Associate Member program is designed for any person, firm, partnership, association or corporation who *supplies goods or services to long-term care facilities in Ohio*. Organizations who have ownership or operational control in any Ohio nursing home, assisted living facility or facility that serves the developmentally disabled are not eligible for Associate membership.

Associate Member dues have been established at \$920.00 per year and must accompany this application. Associate Member applications are approved monthly during the OHCA Board of Director's meeting. Membership begins the first of the month following approval by the OHCA Board of Directors and is renewable annually on the member's anniversary date.

All OHCA Associate Members agree to abide by the Code of Regulations, Bylaws and the relevant Standards and Policies of the Association and may be terminated at any time, and through due process, for failing to meet said standards. Associate membership in OHCA bestows member-only benefits exclusively to employees of the member company. These include Association communications such as *News Bites*, *Bulletins* and *Briefings*; member passwords to access members-only areas of the website; and access to members-only discounts for educational programs. The sharing of these benefits with clients or others not directly employed by the member company is strictly prohibited and cause for termination of membership from OHCA.
